



General Terms and conditions of Business

1. General

All quotations are subject to availability at time of booking and to all traffic rights.

2. Availability

CAT Aviation AG in accordance with the customer reserves the right to provide at any time the customer with another similar aircraft at the same cost should the offered/booked aircraft be unavailable. If no aircraft can be found CAT Aviation AG reserves the right to cancel the order.

3. Travel documents

CAT Aviation AG takes absolutely no responsibility with regards to visa requirements of its passengers. Should there be any levy due to the lack of required entry documents of passengers the customer will be invoiced for such costs.

4. Price

The prices offered are net and do not include any commission.

Any possible war risk insurance surcharge is not included and will be charged separately at cost and reimbursed to CAT Aviation AG by the customer.

CAT Aviation AG reserves the right to charge for special wishes in excess of our high quality standard catering.

The prices offered are subject to industry and related fuel price fluctuation.

5. Terms of Payment
